Dear Friends of Mutera,

We all bear a responsibility for the health and well-being of our communities, and Mutera embraces this duty. Recent United Nations statistics reveal that mental health resources are insufficient and inadequate on a global scale. In the past year alone, a billion children experienced physical, sexual, or emotional violence as well as neglect. Mutera knows well that negative attitudes toward survivors of sexual abuse persist in Uganda, resulting in discrimination against survivors and their families.

To confront this grave issue, Mutera is collaborating with the Ugandan government and other national organizations to eradicate child sexual violence, while strategically deploying trauma-informed Survivor Advocates in various districts across Kampala, Uganda.



Kampala Capital City Authority authorized Mutera to deploy our Survivor Advocates within healthcare centers and police stations. The goal for these advocates is to support survivors by streamlining hospital processes and offering necessary assistance for their journey to healing. These survivor advocates will play a crucial role in recognizing shortcomings or obstacles within the process and will collaborate closely with medical staff and legal advocates to address gaps, to ensure a seamless service for survivors and their families.

In July, Mutera collaborated with Child's i Foundation to organize a unique trauma healing workshop experience designed to provide training to social work and law graduates by equipping them with the skills they will need as Survivor Advocates for victims of child sexual abuse.

Our primary goal was to establish the process of healing for assault survivors, and teach our Survivor Advocates about sexual trauma and the work of advocacy.

Advocates discussed a range of topics including generational trauma, navigating emotions, and identifying cycles of harm. They were then educated on how to intervene to break these cycles as trauma-informed first responders.

Our advocates were organized into groups and tasked with applying the knowledge they had gained over the course of the three-day workshop.
